Thank you, God, for the rest and fun we enjoyed over half-term.


As we return to school, help us to be ready to learn, kind to one another, and thankful for every new day.

Good morning,

I wanted to share an update about the planned road closure at Hatchmere Crossroads, as we know this work is important to many local businesses and residents.

These works were originally scheduled to take place between 22 September 2025 and 2 December 2025, but following feedback from local businesses and the community, we postponed them to avoid disruption at a busy time of year. I'm pleased to confirm that the permit for the revised dates has now been granted.

Key details:

Location: Crossroads at Blakemere Lane, Delamere Road, Ashton Road and School Lane

• **Dates:** 30 March – 9 June 2026

This work has been planned to follow on from the temporary road closure on Norley Road (12 December 2025 – 27 March 2026). The Hatchmere works can only begin once Norley Road has been completed.

We completely understand that road closures can be disruptive, and we really appreciate your patience and cooperation while we carry out these essential improvements.

The closure is needed so we can move key underground valves and pipeline connections currently situated beneath the crossroads into adjacent land. This is quite a complex piece of work, but once it's complete, future maintenance can take place without needing to close the crossroads again – meaning far less disruption in the future.

Access information:

- There will be no vehicle access through the crossroads during this period.
- Pedestrian access will remain open wherever possible, with clear signage in place.

We'll be working closely with local businesses to help keep customers informed and minimise any impact. Regular updates will also be available on our website <u>unitedutilities.com/vamp-live-updates</u>

A summary of queries received during recent community engagement is enclosed and will continue to be updated as the project progresses.

Vyrnwy Aqueduct Modernisation Programme

Can temporary bus stops be added to the No. 48 route at The Carriers Inn and School Lane?

Is there the possibility of providing alternative parking for residents living close to the crossroads?

Will pedestrian access be maintained during the road closure?

Would it be possible to lay metal plates over the excavation to allow vehicles to pass through the working area. Can a vehicle access route be set up over the pavement so vehicles can pass through the crossroads?



Temporary bus stops cannot be added to the No. 48 route at The Carriers Inn or School Lane. We have been working closely with the Cheshire West and Chester Transport Planning Team to explore options, but the proposal is not feasible. The main challenges are the limited size of the turning area at these locations, the large size of the buses required to operate the No. 48 service, and the reliance on private land to complete a turning maneuver safely. These constraints mean that any attempt to add temporary stops could pose safety risks and operational difficulties.

When the No. 48 service is unable to access Hatchmere Crossroads due to the planned closure, buses will need to operate along Norley Road, following a diversion route. This ensures that the service continues to operate, although it will not be able to serve the stops at the crossroads directly.

In addition, we have explored whether the boundary area for the itravel bus could be temporarily extended to include Weaverham High School to provide an alternative option for affected passengers. Cheshire West and Chester Council (CWaC) have confirmed that this is not possible.

We are continuing to engage with local representatives, including Cllr Gill Edwards, to see if any alternative solutions or adjustments can be made to support residents and students affected by the closure. Our aim is to ensure that public transport access is maintained as effectively as possible during this period, and we will provide updates as soon as any viable options are identified.

We have explored the possibility of providing alternative parking for residents living near the crossroads, including the use of Forestry England land, which the project team has previously used as a compound area. However, at this stage it is unclear whether this site will be needed once works in the area begin. Additionally, using the land as a car park would present significant challenges, as it would not be possible to control or restrict access effectively. For these reasons, it has been determined that this option is not viable for providing alternative parking for residents.

Pedestrian access will be maintained wherever possible throughout the road closure. A pedestrian management plan will be implemented to ensure the safety and convenience of all pedestrians in the area which will include temporary walkways. There will be appropriate signage to guide pedestrians safely around the works. The plan will be regularly reviewed and adjusted as the works progress to ensure that pedestrian movement remains safe and accessible at all times.

It is not possible to create a vehicle access route over the pavement through the crossroads. The primary reason is health and safety: the works involve significant excavation and the installation of a secure working area, which must remain in place for the duration of the project to protect both the public and the workforce. Allowing vehicles to pass over the pavement would compromise the integrity of this working area and create a high risk of accidents.

In addition to safety concerns, the pavement and surrounding surfaces are not designed to support the weight and movement of vehicles. Using these surfaces in this way could cause structural damage, create instability, or lead to further hazards, particularly given the depth and extent of the excavation. Temporary measures such as metal plates or movable barriers have also been considered, but these are not feasible due to the size and complexity of the excavation, the layout of the working area, and the need to maintain a secure and controlled environment for construction activities.

Throughout the project, careful planning and pedestrian management will be implemented to maintain safe access where possible, but vehicle access through the crossroads during the works cannot be accommodated.
