How we identify if a child needs additional support

Through careful monitoring and conversations between staff. Pupil progress meetings and conversations with parents. Learning walks,

How we will consult parents & children & involve them in their education

We have regular pupil centred planning meetings-one per term- where parents meet teaching staff and SENDco if required

How we will assess & review pupils with SEND progress towards outcomes

Pupil progress meetings and pupil centred plan meetings. Adaptations are made to the formal assessment process depending on the child's needs

How we will support children in moving between phases of education & / or preparing for adulthood

Through regular meetings and discussions which involve parents, teachers and SENDco. Additional transition days can also be arranged.

Our approach to teaching children with SEND & how we adapt the curriculum & learning environment for pupils with SEND

We make specific adaptations to lessons and planning for individual children depending on their need. We create an inclusive environment where all children are given equal opportunities to thrive and experience the curriculum.

How we train our staff who provide support to pupils with SEND & the existing expertise they have

Staff receive regular training which is often tailored to suit specific needs within school. staff can request training during their appraisals.

How we evaluate the effectiveness of the provision made for pupils with SEND

Through careful monitoring: pupil progress meetings, meeting with teaching staff and parents
